## Lights

Turn on all lights in house and replace burnt out lightbulbs



## Curtains / Windows

Pull drapes, open blinds, and clean windows to see the beautiful outdoors



## Rooms

Remove any clutter and store extra play/misc items in garage or storage area



## Kitchen

Clean off countertops and remove items such as trashcans and paper towels, as well as any refrigerator magnets



## Baths / Showers

Store away shower items such as loofas, soap bars, shampoo bottles, razors, and bath toys



## Pets

Please make sure there are no pets that our photographer has to work around. If pets must be in house, please store in a comfortable room during photos



## Vehicles

When possible, please ensure your driveway is clear of vehicles as well as the immediate areas in front of your house



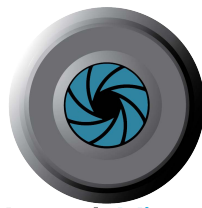
## Other Contractors

1. CLIENT hereby assigns full copyright of photographs taken by MVREP or a representative/ photographer of MVREP to MVREP (and the related representatives and assigns) together with the right of reproduction either wholly or in part.
2. I grant to MVREP the permission to can the above-mentioned photographs either separately or together, either wholly or in part, the perpetual and irrevocable and unrestricted right to use and publish video and/or photographs of me, or where I may be included for editorial trade, product advertising and such other business purposes in any manner and/or medium.
3. If subject of work is outside Mountain House proper, MVREP reserves the right to add a reasonable transportation fee.
4. MVREP guaranties AGENT a professionally produced product. If the product created is not acceptable based on reasonable standards, MVREP will refund client's fees in whole, or in part depending on the portion of the project that CLIENT is not happy with. The amount of the refund is ultimately up to MVREP and its' representatives . CLIENT will not be eligible to receive or use any part of photographs or recordings if fees have been refunded.
5. If the product is unacceptable to AGENT from an editing standpoint, MVREP will re-edit footage a second time based on written notes provided by the client. IF this second edit is unacceptable, MVREP will charge an hourly fee to continue refinement of media.
6. If a legal dispute arises with regards to the business conduct or representative's actions while contracted by MVREP, CLIENT agrees to a privately mediated settlement.
7. CLIENT will provide a "show ready" property at the time arranged for the recording. MVREP will not be responsible for "preparing" the subject property for the recording. If the recording of the property is unacceptable based on the condition of the property or its contents, MVREP will charge a minimum of \$100 to re-record the property, plus any travel expenses.
8. MVREP is not responsible for weather-related detrimental effects of recording.
9. MVREP agrees to maintain a reasonable amount of liability insurance to protect the contents of subject property from damage caused by any MVREP representative.

- a. CLIENT agrees that if a project has to be canceled, CLIENT will do so a minimum of 24 hours prior to the scheduled shoot time, otherwise, no refund will be given to CLIENT by MVREP .

I agree that the above-mentioned photographs and any reproductions shall be deemed to represent an imaginary person, and further agree that MVREP or any person authorized by or acting on FIF's behalf may use the above-mentioned photographs or any reproductions of them for any advertising purposes or for the purpose of illustrating any wording, and agree that no such wording shall be considered to be attributed to me personally unless my name is used.
